At the World Congress held in Curitiba, Brazil in November 2010, the following membership requirements were approved for implementation during a 2 year transitional period. That is, by the date of the next ITKF World Congress to be held in 2012 in Warsaw, Poland, the following requirements are to be met for each Category of Membership held in ITKF by National Federations.

## ORGANIZATIONAL STRUCTURE

- 3.1 <u>Composition</u>
  - ITKF shall be comprised of member organizations which are established voluntarily and democratically in their own countries as the sole governing body of Traditional Karate in their respective countries. Participating Organizations

It is necessary that each member organization in ITKF have satisfied the following qualifications set out in paragraphs (1) to (6) below:

5. Must have two or more technical officials who have ITKF technical qualifications.

### FULL MEMBER

- All Board of Directors & Technical Officials ITKF Registered Black
  Belts
- All members recognized ITKF ESO's
- Minimum of 30 clubs registered or 3 different ITKF ESO's representing 20 clubs
- 30+ ITKF current qualifications
- All Black Belts ITKF Dan registration
- Host a minimum of 2 ITKF sanctioned events per year
- National Federation has 2 votes at all ITKF General Meetings

### **REGULAR MEMBER**

- All Board of Directors & Technical Officials ITKF Registered Black
  Belts
- All members recognized ITKF ESO's
- Minimum 20 clubs registered or 2 different ITKF ESO'S representing
   15 clubs
- 20+ ITKF current qualifications
- All Black Belts ITKF Dan registration
- Host a minimum of 1 ITKF sanctioned event per year
- National Federation has 1 vote at all ITKF General Meetings

### ASSOCIATE MEMBER

- Minimum of 5 Technically Qualified Officials
- Minimum of 5 ITKF registered Black Belts
- Minimum of 15 registered clubs
- Host minimum of 1 ITKF sanctioned event every two years
- All members ITKF recognized ESO's
- No voting privileges

### **PROVISIONAL MEMBER**

- Minimum of 2 Technically Qualified Officials
- Minimum of 5 ITKF registered Black Belts
- Minimum of 10 registered clubs
- At least one member group recognized ITKF ESO
- Must attain Associate Member status within 3 years of acceptance
- Must hold minimum of 2 ITKF sanctioned events within 3 year period
- No voting privileges
